\*\*\*\*\* Those eligible as part of the maximum cost of \$1,675 per family include the parents and siblings of the child with diabetes only.

### **FINANCIAL ASSISTANCE**

Please be aware that **our campership funding is limited**. Camperships are awarded on a **first-come, first-served, sliding-scale basis**, in the order in which completed applications are received. **DEADLINE TO APPLY FOR FINANCIAL AID IS WITHIN TWO WEEKS OF CAMP REGISTRATION. YOUR APPLICATION MUST BE ACCOMPANIED BY A COPY OF YOUR 2018 FEDERAL TAX RETURN. IF YOU HAVE NOT COMPLETED YOUR TAXES, PLEASE SEND 2017 FEDERAL TAX RETURN AND 2018 W-2 FORMS. IF TAX RETURN IS NOT RECEIVED, CAMPER REGISTRATION IS CANCELLED.** You will be notified of eligibility for financial assistance by mail or email. **Campers who receive financial assistance from The Barton Center will not be enrolled in more than one summer session.**

### **MEDICAL SUPPLIES**

Fees indicated include most diabetes and routine medical supplies and care. Please do not bring meters, lancets, syringes, insulin, or low blood sugar treatment supplies to camp with you. All campers using an insulin pump or blood glucose sensor should bring their own insulin pump supplies (excluding insulin) and/or sensor equipment (this includes pump batteries). **Prescription medications ordered while at camp will be billed separately.**

### **CANCELLATIONS**

Cancellations **MUST BE MADE IN WRITING OR EMAILED (info@bartoncenter.org) AT LEAST 30 DAYS PRIOR TO THE SESSION OPENING.** Registration fees are nonrefundable, nor can they be applied to other programs. **Camp fees will NOT be refunded for cancellations made within 30 days of the session opening**, unless a documented emergency has occurred. **Campership recipients are not eligible for financial assistance in subsequent years if the cancellation policy is not followed—THIS INCLUDES CAMPERS WHO DO NOT SHOW UP AT A SESSION.** In the event a camper chooses to leave early **for any reason** or is asked to leave for inappropriate behavior, no refund is allowed. **YOUR ADVANCE NOTICE OF ANY CANCELLATION ALLOWS US TO FILL YOUR VALUABLE SPACE WITH A CAMPER FROM OUR WAITING LIST.**
